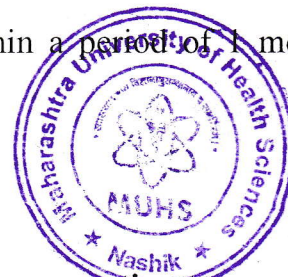
Sir / Madam,

As per provision of section 65(4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of Local Inquiry Committee report and Circulatory permission from Academic Council, the Hon'ble Vice Chancellor is pleased to grant the First Time Affiliation **Backward Class Youth Relief Committee, Bhausaheb Mulak Ayurved College, Gret Nag Road, Nandanvan, Nagpur (Maharashtra) for the Academic Year 2021-22, for Increase in Intake Capacity from 60 to 100 seats of B.A.M.S. (UG) course.**

- 7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college / Institute.
- 8) Bank Guarantee should be submitted within a period of 1 month from the date of issuance of this letter to the University.
